



Buy American Compliance USDA Child Nutrition Programs

Section 104(d) of the William F. Goodling Child Nutrition Reauthorization Act of 1988 requires school food authorities (SFAs) to purchase to the maximum extent practicable, domestic commodities or products. The Buy American provision defines “domestic commodity or product” as an agricultural commodity that is produced in the U.S. and a food product that is processed in the U.S. substantially using agricultural commodities produced in the U.S.

For foods that are unprocessed, agricultural commodities must be domestic, and for foods that are processed, they must be processed domestically using domestic agricultural food components that are comprised of over 51% domestically grown items, by weight or volume as determined by the SFA. Products from Guam, American Samoa, Virgin Islands, Puerto Rico, and the Northern Mariana Islands are considered domestic products under this provision as these products are from the territories of the U.S.

Accordingly, our cereals and peanut butters listed below are processed in the U.S. substantially using over 51% (by weight or volume) agricultural commodities produced in the U.S. in compliance with the Buy American Provision.
